Class rules and information:

To facilitate compliance, I request that students turn off and put away all electronic devices before class begins. The course will cover Constitutional Principles which confront both prosecution and defense attorneys. The area of criminal procedure is constantly changing and developing. We will explore those changes and developments with a particular focus on the Supreme Court's interpretations of the Fourth (search and seizures), Fifth (self-incrimination), and Sixth (right to counsel in the investigatory stage) Amendments.
