I. COURSE DESCRIPTION AND OBJECTIVES

This course is designed to prepare you for bar exam by focusing on skill development. Specifically, you will receive in-depth skill instruction on reading comprehension, issue identification, rule mastery, critical thinking, legal analysis and recognition of distractors. You will also gain a strong conceptual understanding and knowledge of highly tested doctrines and will be taught how to develop, use, and apply a flexible but strong analytical framework to solve bar exam problems.

II. COURSE REQUIREMENTS, ATTENDANCE POLICY AND GRADING

A. You are expected to complete the reading and homework assignments **prior to each class**. This will include uploading completed assignments to the Matrix course site. You may be given additional assignments during class. Your Professor reserves the right to change assignments with sufficient notice.

250 points Final Exam – Your final exam will consist of 100 multiple-choice questions. The subject matter for the exam will be the material covered in the outlines, information included in your lecture notes, and course materials, dating from the beginning of class.

50 points Midterm Exam – You will be given a midterm exam which will consist of multiple-choice questions. The subject matter for the exam will be the material covered in the outlines, information included in your lecture notes, and course materials, dating from the beginning of class.

50 points Graded Assignments – Completion of all AMP modules outside of class. Each BarBri AMP module must be completed online. The professor will be able to track each student’s progress to ensure all modules are completed, so ensure that they are completed when scheduled.

50 points The professor will give five (5) quizzes during the semester, worth 10 points each. There will be no makeup examinations for these quizzes. If you are not present in class, you will receive a zero on that quiz. Quizzes will be multiple choice question form.

Bonus Lecture Handouts – You will be given an additional 10 points for submitting proof that all videos have been viewed by providing an outline of the substance of each video.
