Business Organizations will be offered every semester.</p> <p>2 – Second year full-time students must take Constitutional Law II, Evidence and Professional Responsibility in Fall 2017.</p> <p>3 – Second year full-time students must take Criminal Law in either the Fall Semester or Spring Semester of the 2017-2018 academic year.</p> <p>4 – Completion of the following courses is highly recommended before enrolling in Florida Bar Law &amp; Skills: Wills and Estates, Family Law, and Florida Constitutional Law.</p> <p>5 – Evidence is the only prerequisite for Trial Practice.</p> <p>6 – <b>ONLY</b> Seminars and Independent Research Projects satisfy the Upper-Level Writing Requirement.</p> <p>7 – Students may not withdraw from clinics after the end of the Add/Drop period.</p> <p>8 – Students enrolling in a clinic must attend a mandatory orientation on <b>TBA</b> at 8:00 am &amp; 5:00 pm in the Clinic Conference Room (Rm. 184).</p> <p>9 - Registration by application and permission <b>ONLY</b>. To register, students must complete two steps. First, the student must submit an approved outline and application signed by the Professor who will supervise and evaluate the research paper. Second, students must submit the signed applications to the Associate Dean for Academic Affairs for final approval. The supervising faculty member must be a member of the full-time faculty who does not teach in the Legal Methods Program or in the Academic Success and Bar Preparation Program.
