FALL 2021 COURSE SCHEDULE – *updated August 3, 2021*

SCHEDULE NOTES – Please review these notes for important information regarding the Fall 2021 course schedule.

1. Fall 2021 classes begin on Monday, August 16, 2021 and end on Tuesday, November 16, 2021. Tuesday, November 16 is the make-up day for Veteran's Day, and a *Thursday* class schedule will be in effect on this final day of classes.
2. The reading period is subject to change in the event inclement weather or other extraordinary conditions occur during the semester and necessitate additional class make-up days at the end of the semester. Students should not make travel plans during the scheduled reading period.
3. Second year full-time students must take the following courses in Fall 2021: Constitutional Law II and Evidence.
4. Second year full-time students must take Professional Responsibility in Fall 2021 or Spring 2022. Professional Responsibility will be offered in a day section and an evening section in Spring 2022. Both sections are open to part-time and full-time students.
5. Prerequisite for Trial Practice – Evidence.
6. Trial Practice Sections Taught by Judge Whitehead – Sections 301 and 302 are scheduled to meet at the Orange County Courthouse, Courtroom 18-C.
7. Trial Practice Sections Taught by Judge Allen – Sections 301 and 302 are scheduled to meet at the Orange County Courthouse, Courtroom 4-A.
8. Upper-Level Writing Requirement – Students may satisfy the Upper-Level Writing Requirement via a seminar, independent research paper, in an approved advanced drafting course or by writing a note as a member of the FAMU Law Review that is accepted for publication in a co-curricular law school journal and is certified by the faculty advisor for the FAMU Law Review. 9. Law Clinic Registration – Application and permission are required. Students are required to have completed the Professional Responsibility course before applying for a clinic. The relevant forms and information are available on the webpage at <https://law.famu.edu/students/current-students/registrar/forms/>. Applications are due to the Clinic Office no later than Friday, August 6. ***Please note that clinic seats may fill before this deadline, and when all seats are taken, clinic enrollment will close.*** Once a student accepts an offer for a clinic position, the Registrar's Office will provide a registration permission number for course registration. Accepted students are not permitted to drop the clinic without approval of the Clinic Office. Students may not withdraw from clinics after the end of the Add/Drop period. Please contact Professor Kim Crag-Chaderton if you have questions.
10. Law Clinic Mandatory Orientation – Students enrolling in a clinic must attend a mandatory orientation. The clinic faculty will set the date and time of the orientation.

11. Field Placement Registration – Application and permission are required. Applications are due to the Clinic Office no later than Friday, August 6. *Please note that field placement seats may fill before this deadline, and when all seats are taken, field placement enrollment will close.* Field placement enrollment is not final until approved by the Associate Dean for Academic Affairs. Students who are approved to enroll in field placement will be notified by the Clinic Office via email. The Registrar's Office will provide a registration permission number for course registration. *The Field Placement Faculty will notify enrolled students of the meeting day and time for the mandatory professional development tutorials.* Please contact Professor Kim Crag-Chaderton if you have questions.
12. Independent Research – Application and permission are required. To register, students must (1) submit an approved outline and application signed by the faculty member who will supervise and evaluate the research paper and (2) submit the signed application to the Associate Dean for Academic Affairs for final approval. The supervising faculty member must be a member of the College of Law full-time faculty. The completed application must be submitted to the Associate Dean for Academic Affairs no later than 5:00 p.m. on Friday, August 13. LATE APPLICATIONS WILL NOT BE APPROVED. 13. Directed Individualized Study – Application and permission are required. To register, students must (1) submit an approved outline and application signed by the faculty member who will supervise and evaluate the student's work and (2) submit the signed application to the Associate Dean for Academic Affairs for final approval. The supervising faculty member must be a member of the College of Law full-time faculty. The completed application must be submitted to the Associate Dean for Academic Affairs no later than 5:00 p.m. on Friday, August 13. LATE APPLICATIONS WILL NOT BE APPROVED. 14. Research Associate – Application and permission are required. To register, students must (1) submit an approved outline and application signed by the faculty member who will supervise and evaluate the student's work and (2) submit the signed application to the Associate Dean for Academic Affairs for final approval. The supervising faculty member must be a member of the College of Law full-time faculty. The completed application must be submitted to the Associate Dean for Academic Affairs no later than 5:00 p.m. on Friday, August 13. LATE APPLICATIONS WILL NOT BE APPROVED. 15. Teaching Fellow – Application and permission are required. To register, students must (1) submit an approved outline and application signed by the faculty member who will supervise and evaluate the student's work and (2) submit the signed application to the Associate Dean for Academic Affairs for final approval. The supervising faculty member must be a member of the College of Law full-time faculty. The completed application must be submitted to the Associate Dean for Academic Affairs no later than 5:00 p.m. on Friday, August 13. LATE APPLICATIONS WILL NOT BE APPROVED. 16. Moot Court and Trial Team – Moot Court and Trial Team are open only to students representing the College of Law on teams competing in state, regional, or national competitions.
