#### Requirements for the J.D. degree:

- To satisfy the "Upper-Level Writing Requirement," students may either complete an Independent research project paper for 2 credits or a paper in a seminar course (review the current Student Handbook for more details).
- Earn a cumulative grade point average of 2.00 or better for all law school courses taken.
- Be approved by COL Faculty.
